

### 2415.04 TITLE I - DISTRICT-WIDE PARENTAL INVOLVEMENT

As a school district that receives Title I funds, the Waterford Township School District shall implement programs, activities and procedures for the involvement of parents/guardians in programs assisted by Title I funding. The district will reserve not less than one percent of its allocation under Subpart 2 to carry out these requirements (unless the district's allocation is \$500,000 or less), which shall include promoting family literacy and parenting skills. Parents/guardians of students receiving Title I services shall be involved in the decisions regarding how funds will be allotted for parental involvement activities.

The district shall distribute this parental involvement policy that describes the means for carrying out the requirements of No Child Left Behind Act (NCLB) OF 2001, §1119(a) through (f). Parents/guardians will be notified of this policy in an understandable and uniform format and, to the extent practicable, provided in a language the parents/guardians can understand. This policy shall be made available to the local community and updated periodically to meet the changing needs of the parents/guardians and schools within the district.

"Parent", for the purposes of this policy, means a parent and/or legal guardian. "School", for the purposes of this policy, is a specific school in a Target Assistance Title I program or schools within the district in a school-wide Title I program.

#### A. Policy Involvement

1. Each school served with Title I funds will:
  - a. Convene an annual meeting (at a District Parent Interaction), to which all parents of participating students shall be invited and encouraged to attend and inform parents of their school's participation and the requirements of this policy and the right of the parents to be involved;
  - b. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation or child care, as such services relate to parental involvement; and
  - c. Involve parents in an organized, ongoing and timely way, in the planning, review and improvement of programs, including the planning, review and improvement of the school parental involvement policy and the joint development of the school-wide program plan under NCLB §1114(b)(2).



2. Provide parents of participating students:
  - a. Timely information about programs required by NCLB §1118;
  - b. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet;
  - c. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicably possible; and
  - d. Submit any parent comments on the plan where the school makes the plan available to the Board of Education, if the school-wide program plan under NCLB §1114(b)(2) is not satisfactory to the parents of participating students.

### B. Shared Responsibilities for High Student Academic Achievement

Each school served by Title I funds shall jointly develop with parents of all students served with Title I funds, a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the State's high standards. The compact will:

1. Describe the school's responsibility to provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the students served by Title I funds to meet the State's student academic achievement standards, and the ways in which each parent will be responsible for supporting their children's learning, such as monitoring attendance, homework completion, and television watching; volunteering in their child's classroom; and participating, as appropriate, in decisions relating to the education of their children and positive use of extracurricular time.
2. Address the importance of communication between teachers and parents on an ongoing basis through, at a minimum:
  - a. Parent-teacher conferences in elementary schools, at least annually, during which the compact shall be discussed as the compact relates to the individual student's achievement;



- b. Frequent reports to parents on their children's progress; and
- c. Reasonable access to staff, opportunities to volunteer and participate in their child's class, and observation of classroom activities.

### C. Building Capacity For Involvement

To ensure effective involvement of parents and to support a partnership among the school(s) involved, parents, and the community to improve student academic achievement, each school and school district assisted with Title I funds:

1. Shall provide assistance to parents of students served by the school in understanding such topics as the State's academic content standards and State student academic achievement standards, State and local academic assessments, the requirements of this policy, and how to monitor a child's progress and work with educators to improve the achievement of their children;
2. Shall provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement;
3. Shall educate teachers, student services personnel, Building Principals, and other staff with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to communicate with and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school;
4. Shall, to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities with Reading Recovery, Reading First, Even Start, the Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents to more fully participate in the education of their children;
5. Shall ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and to the extent practicable, in a language that parents can understand when requested;
6. May involve parents in the development of training for teachers, Principals and other educators to improve the effectiveness of such training;

7. May provide necessary literacy training from Title I funds if the school district has exhausted all other reasonably available sources of funding for such training;
8. May pay reasonable and necessary expenses associated with local parental involvement activities, including transportation or child care to enable parents to participate in school-related meetings and training sessions;
9. May train parents to enhance the involvement of other parents;
10. May arrange school meetings at a variety of times, or conduct phone conferences between teachers or other educators who work directly with participating children with parents who are unable to attend such conferences at school in order to maximize parental involvement and participation;
11. May establish a district-wide parent advisory council to provide advice on all matters related to parental involvement in Title I programs;
12. May develop appropriate roles for community-based organizations and businesses in parent involvement activities; and
13. Shall provide such other reasonable support for parental involvement activities under this policy as parents may request.

### Accessibility

In carrying out the parental involvement requirements of NCLB §1118 and this policy the school and school district, to the extent practicable, shall provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, to include providing information and school reports required under NCLB §1111 in a format, and to the extent practicable, in a language such parents understand.

The district will inform parents of any parental information and resource centers that provide training, information and support to parents and individuals who work with local parents, school districts and schools receiving Title I funds.

The Superintendent of Schools will submit this policy to the New Jersey Department of Education for review to be sure the policy meets the requirements of NCLB §1118.
